


VENDORS: OPTING OUT OF NOTIFICATIONS

Notifications – Any communication received specifically related to a project or for a bid opportunity.

How to Stop Receiving Email Notifications for New Projects

If you no longer wish to receive notifications about new/available projects on PennBid, follow these steps:

1. Go to “My Account” and click “Edit” under the Categories bar.


